- ▶ Vietnam National Academic Recognition Information Centre (VN-NARIC), the designated Vietnam national agency for the recognition of international qualifications and verification of international and Vietnamese qualifications, was established in March 2016. It performs on behalf of the Department of Quality Management - Vietnam Ministry of Education and Training (Public service).
- ▶ VN-NARIC receives and implements recognition of approximately 6000 foreign degrees and verification of 10.000 – 15.000 Vietnamese degrees annually.
- ▶ VN-NARIC provides information on Vietnam education system, recognized Vietnamese higher education institution.

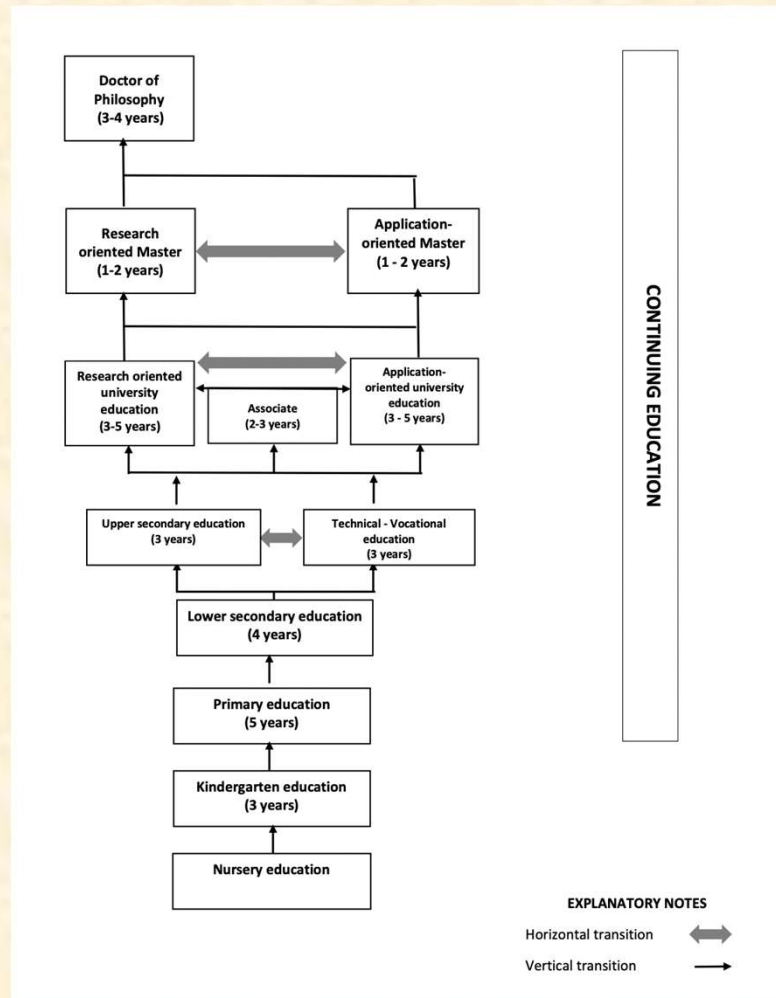

I. GENERAL EDUCATION SYSTEM



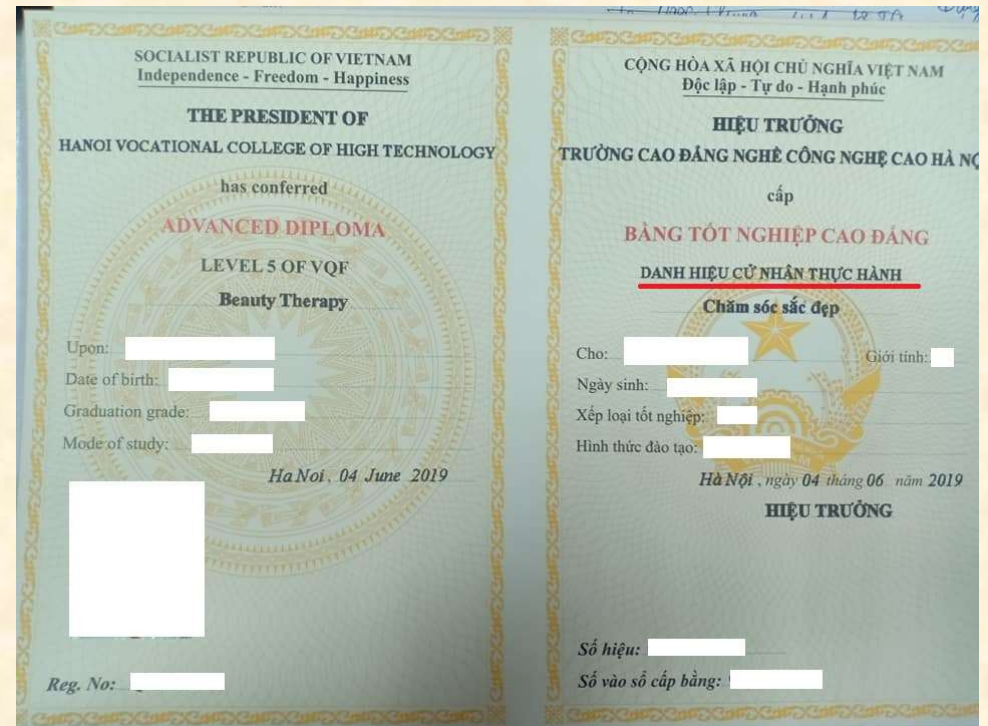
The national education system of Vietnam:

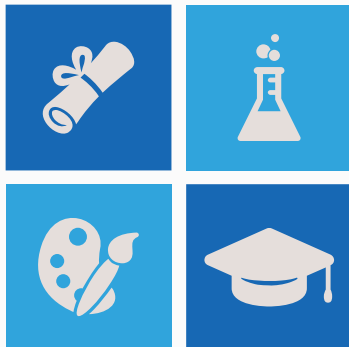

I. LEGAL DOCUMENTS

- Article 109 of Education Law No. 43/2019/QH14 dated June 14, 2019
- Circular No. 13/2021 dated April 15, 2021 of the Minister of Ministry of Education and Training stipulating the conditions, order and competence to recognize diplomas issued by foreign educational institutions for use in Vietnam

II. DOSSIER AND PROCEDURE

2.1. DOSSIER

- One (01) copy of the diploma, enclosed with its Vietnamese translation authenticated by a competent agency
- One (01) copy of the academic transcript given by the foreign educational institution, enclosed with its Vietnamese translation authenticated by a competent agency; entry diploma.
- Proof of studying abroad time (if any)

2.2. WORKING DURATION

- 20 working days
 - No longer than **45 working days** if the case needs **information verifying**

II. DOSSIER AND PROCEDURE

2.3. RECOGNITION RESULT

- The recognition result is recorded on the **recognition paper**
 - **Official dispatch** if a diploma is not eligible for recognition or beyond the 45-day time limit, there are not enough proof to verify information about the diploma
 - If it is **impossible to determine the equivalent level in the Vietnam National Qualifications Framework**, the Education Quality Management Agency shall provide **information and recognize the value of the diploma** according to the educational system of the home country.

III. CRITERIA AND CONDITIONS FOR DIPLOMA RECOGNITION

- Study or research duration is consistent with the Vietnam National Qualification Framework and
 - **The program** is accredited by accreditation agency of the home country, correspondence to mode of delivery or;
 - **The education institution** is recognized/accredited by the national education authorities or accreditation agency of the home country
 - Diplomas granted by a foreign education institution operating (teaching provided) in different countries from headquarter (including Vietnam) shall be recognized when such education institution is approved by the competent educational authorities of the home and host country.


III. CRITERIA AND CONDITIONS FOR DIPLOMA RECOGNITION

- **Diplomas whose mode of delivery is online or blended mode shall be recognized when the program is accredited by accreditation agency of the home country and**
 - **The training program authorized by the MOET to provide in Vietnam when students reside and study in Vietnam or;**
 - **The training program is authorized by the competent education authority of the country where the training is organized when student reside and study in that country.**

 - **The recognition of foreign diplomas due to force majeure shall be comply with decision of the Minister of MOET.**

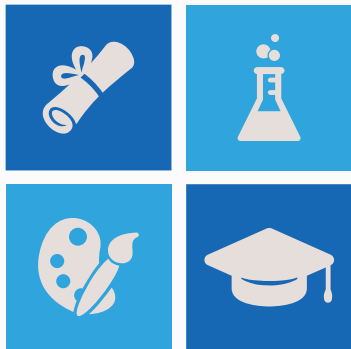

I. QUALITY ASSURANCE IN VIETNAM

Approval system for establishment of HEI

- The Prime Minister holds the authority to establish public universities and private universities. The Ministry of Education and Training (MOET) allows the operation of these schools.
- Decree No. 46/2017/ND-CP dated April 21st, 2017 of the Vietnam Government prescribes regulatory requirements for establishing and abolishing a higher education institution.

II. HIGHER EDUCATION ACCREDITATION IN VIETNAM

- Recognized HEIs are allowed to provide training programmes and issue degrees in Vietnam.
- Education accreditation is a new concept in Vietnam. It is regulated in Vietnam Education Law. HEIs in Vietnam are required to perform this activity, however HEIs are allowed to choose the time to undergo this procedure.
- 2015 was when the first HEIs in Vietnam were accredited.

II. HIGHER EDUCATION ACCREDITATION IN VIETNAM

- MOET is currently updating the list of accredited/recognized HEIs and programs on their website: <https://moet.gov.vn/giaoducquocdan/khao-thi-va-kiem-dinh-chat-luong-giao-duc/Pages/Default.aspx>
 - As of October, 2021, **164 HEIs (e.g. university, academy) and 10 pedagogical colleges** have been accredited.
 - As of October 2021, **497 programs** have been accredited. In which there are **279 programs** have been accredited in accordance with **domestic standards** and **218 programs** have been accredited in accordance with **international standards**.

II. HIGHER EDUCATION ACCREDITATION IN VIETNAM

There are **07 authorized domestic centers** for education institutions accreditation in Vietnam.

FUTURE MOVEMENT

- Relevant departments of MOET identify and propose method for teaching and assessment to online learning programs affected by COVID-19 pandemic.
- MOET drafts a project named "Increasing information technology application and digital transformation in education and training in the period of 2021-2025".
- For degree recognition: Already have policy to recognize partly online and 100% online degrees which are influenced by COVID-19.
